In Reception, we use 2Simple/Evidence Me to share your child's learning with you via email.

When we send reports to you by email, photographs will be included. If a photograph is taken during a group activity, other children will appear in the photograph. This means that your child's image may be emailed to other parents, if the photograph is taken during a group activity.

At the end of the year, we would like to give you a print out of your child's learning journey. This will include photographs taken during group activities. This means your child's image may be included in other children's learning journeys.

- I give consent for you to share my child's image with other Foundation Stage parents, using 2Simple/Evidence me, where the image is taken during a group activity.
- I give consent for you to share my child's image with other Foundation Stage parents, as part of the learning journey, where the image is taken during a group activity.
- I give consent for you to send my name and email address to 2Simple/Evidence Me.
- I give consent for you to send my child's data to 2Simple/Evidence Me so that they can set up a profile, I understand that they need the Unique Pupil Number (UPN), name, date of birth, and class.

We take children out of school on trips and visits. If we take them on a local walk, e.g. to the library, we will let you know about the trip by publishing the details in the weekly newsletter.

- I give consent for my child to be taken out of school to walk in the local area. I understand that I will be informed of the date and time in advance, through the weekly newsletter.

As part of our Personal, Social and Health Education curriculum, we teach relationships and sex education in an age appropriate way in keeping with our Catholic values.

- I withdraw my child from sex education. I understand I cannot withdraw my child from relationships education or the aspects of the science curriculum which include some elements of sex education.

The NHS School Nursing Service visit school to measure height, weight, hearing and vision. We share data, so that they can issue consent letters to the parents.

- I give consent for my child's name, date of birth and address to be shared with the NHS School Nursing Service.

We use School Grid for the ordering and payment of school meals and ParentMail for school communication and other payments.

- I give consent for you to send my name and email address to School Grid and ParentMail, so that they can set up my account.

As support of our curriculum or in circumstances such as end of term rewards or extended indoor breaks, we may wish to show your child part or whole films. Whilst permission is not required for films with U certificates, we may sometimes choose carefully selected PG films.

Intimate Care

Examples of intimate care can include help with washing, toileting or dressing. It also includes supervision of children involved in intimate self-care. There may be occasions when your child has an accident linked to toileting and will need help to be cleaned and change clothes. If permission below is not given, parents will be contacted to organise for their child to be cleaned and changed. If parents or emergency contacts cannot be contacted, staff will act appropriately in the best interests of the child.
